## **KEYNOTE ADRESS**

# PROFESSOR KATHERINE NEWMAN Failure to Launch? The Complications of Delayed Departure from the Natal Home in Western Europe, Japan & the U.S.



The age at which young adults leave the parental home has been rising in all developed nations. This cultural shift is related to other ways in which the advancement into adulthood has slowed down in recent decades, including young people taking longer to finish school, to marry and begin a family. Many are living at home longer as a response to high housing costs and fewer and less stable employment opportunities. This trend or "failure-tolaunch" is likely to persist. In her keynote address, Professor Newman will report on a six-country study

she and her collaborators recently completed on the prolonged stay of young people in their parents' homes. The presented study is also the basis of her current book project.

**Katherine Newman** is the Malcolm Stevenson Forbes, Class of 1941 Professor of Sociology and Public Affairs at Princeton University, where she also directs the Institute for International and Regional Studies. Formerly the Dean of Social Science at the Radcliffe Institute for Advanced Study at Harvard University and the Malcolm Wiener Professor of Urban Studies in the John F. Kennedy School of Government, Professor Newman has written eight books on topics ranging from urban poverty to middle class economic insecurity to school violence. Professor Newman is the recipient of several awards, including the Robert F. Kennedy Memorial Book Prize and the Hillman Book Award and appears frequently on public radio and television.

#### PUBLIC SOCIOLOGY AWARD Wilder Research

Each year, we recognize the importance of public sociology—efforts that engage wider audiences in understanding how we work and how change happens. This award honors those involved in community organizing, advocacy, or social services drawing upon a distinctly sociological perspective, and/or are conducting research or teaching that directly informs public debates and involves broader publics.

This year's recipient is **Wilder Research** in recognition of the launch of *Twin Cities Compass*.



Wilder Research in partnership with the Itasca Project, several foundations, and other groups interested the vitality of our region, recently established *Twin Cities Compass* to provide a common foundation to identify, understand and act on community issues that affect the Twin Cities and surrounding communities. By tracking topics that impact quality of life, including civic engagement, early childhood, economy and workforce, education, health, housing, public safety and transportation, they provide unbiased, credible information about how our region is faring; to alert policy makers, community leaders and the public to significant trends; to promote coordinated efforts to address them; to measure and communicate progress; and identify solutions and build consensus to promote productive action.

More than 300 volunteers including educational institutions, private industry, public and non-profit sectors have helped to shape *Twin Cities Compass*. Through presentations, their web site <u>www.tccompass.org</u>, and most recently on Facebook, Wilder Research reports new findings, discusses how issues are being addressed, and informs groups working to promote positive change in our region.

#### From a nomination letter:

The project is a marvelous effort to bring together basic demographic information and social facts about the Twin Cities and making these data accessible for broad public audiences.



The Amherst H. Wilder Foundation was founded in 1906. It is a non-profit health and human services organization. Its research division, Wilder Research, has a history of conducting community engaged studies of pressing social issues such as homelessness, poverty, child care, and immigration.

Professor David Knoke is this year's recipient of the CLA Arthur "Red" Motley Exemplary Teaching Award. This award "acknowledges tenured or tenuretrack faculty who inspire and care, who make themselves approachable, who show an interest in individual students' well-being and in programs for the benefit of students generally, who give of themselves generously in advising, counseling, and directing projects, and who create an active classroom atmosphere. Such faculty provide a model to undergraduate and graduate students through their own research and



teaching, and leave an impression by their efforts which alumni recall with appreciation and esteem." The formal presentation of this award will be made at the undergraduate commencement ceremony, Sunday, May 17<sup>th</sup>.



Professor Teresa Gowan received the 2008 CLA Student Board Outstanding Professor Award. CLA students honor one faculty member per year for this prestigious honor for excellence in teaching and mentoring of undergraduate students.



Professors Enid Logan and Teresa Swartz were awarded the 2008-09 President's Faculty Multicultural **Research Award** which is designed is to encourage and support research on issues related to people of color in the United States. Professor Logan's project is On Dreams Deferred and American Dreams: African-American Perspectives on Immigration and



Race in the Contemporary U.S and Professor Swartz's Growing Up But Not Apart: Intergenerational Relations and the Transition to Adulthood.



Professor Emeritus Ron Anderson received the Graduate School Award for Research. This year, the Graduate School offered 12 small, competitivelyawarded grants for Professional Development to University retirees. Ron Anderson received one of these for his research on "Comparative Social Well-Being during Financial Crisis." He is preparing and will soon release an Index of Social Well-Being (including 42 separate indicators) for the 20 most affluent nations. The grant will help to internationally track and report

about research on the social effects of the current economic crisis in these 20 wealthy societies, with special focus on the United States.

## **GABRIELLE FERRALES**



Gabrielle Ferrales will be completing her Ph.D. in Sociology from Northwestern University and joining our department in the fall. She received her J.D. from Georgetown University of Law and practiced law until she entered the sociology graduate program at Northwestern. Her dissertation, "Invasion by Female": Gender-Based Violence and the Rule of Law in the United States, Iraq, and Dafur supported by the American Bar Foundation, is a comparative study of court responses to gender based violence in domestic and international contexts including the US, Sudan, and Iraq. She uses a

multi-method approach, including ethnography, interviews, case analysis, factorial surveys, and victimization surveys, to examine how legal institutions use gender norms to conceptualize violence and how this produces new opportunities within the law to re-victimize women. Her earlier work was published in journals in law and the sociology of law and she received awards from the American Sociological Association and the Society for the Study of Social Problems. She has also been a guest lecturer/teaching assistant for courses in the Sociology of Law.

# Resisting Global Toxics: Transnational Movements for Environmental Justice

Every year, wealthy nations and corporations in the global North produce millions of tons of toxic waste. Too often this hazardous material—linked to high rates of illness and mortality and widespread ecosystem damage is exported to poor communities of color around the world. This presentation demonstrates that waste dumping across national boundaries from rich to poor communities can be theorized more effectively through an analysis of the social categories of race, class, gender, nation, and environment. Building on environmental justice studies, environmental sociology, and race theory, and drawing on archives, interviews, and participant observations, this presentation highlights the phenomenon of global environmental inequality and considers the emergence of transnational environmental justice movements to challenge and reverse it.

David Pellow, the first Don A. Martindale Endowed Chair in Sociology,



received his PhD from Northwestern University in 1998. Prior to joining our faculty he was professor of sociology in the Ethnic Studies Department at University of California-San Diego. His first soleauthored book, *Garbage Wars: The Struggles for Environmental Justice in Chicago*, won three sociology awards, including the C. Wright Mills award. David is an intellectual leader in theorizing race and social inequality as it pertains to workplace and communitybased industrial and environmental hazards, as well as


the politics and strategies of social movements emerging from these vulnerable communities. He continues to work on transnational environmental justice movements and global policy frameworks concerning sustainability. He is also working on a study of environmental, labor, and immigration conflicts in Colorado's Roaring Fork Valley.

#### The Legacy of Don A. Martindale

Don A. Martindale was a distinguished member of the sociology faculty from 1948, when he was hired as an Assistant Professor, until he retired as Emeritus Professor in 1983. Professor Martindale's ability as social analyst and social theorist is evident in his extensive and highly regarded body of writings. During his career he guided 78 graduate students through the PhD degree program. As a passionate defender of students, he was sought out for his guidance and independent judgment.

  - Two blocks away from the 19th Ave. Ramp. Enter ramp on 21st Ave. So., 1/2 block from Riverside and 21st Ave. So.
